The delegation of Uruguay, acting on behalf of LAIA member countries which are contracting parties to the General Agreement, has forwarded the following communication dated 24 March 1987.

In accordance with provisions relating to the GATT Enabling Clause, I have pleasure in forwarding herewith the report on actions taken in the sphere of the Latin American Integration Association during the period 1984-86.

INFORMATION ON IMPLEMENTATION OF ENABLING CLAUSE PROVISIONS

(1984-1986)

In pursuance of paragraph 4(a) of the Decision adopted by the CONTRACTING PARTIES on 28 November 1979 regarding "Differential and More Favourable Treatment, Reciprocity and Fuller Participation of Developing Countries", the delegations of Argentina, Brazil, Colombia, Chile, Mexico, Peru and Uruguay, countries being members of LAIA and at the same time contracting parties to the General Agreement, bring the following information to the knowledge of the General Agreement.

1. First of all, the accession of the United Mexican States to the General Agreement modifies the terms of the last report, submitted in September 1984, as regards that country's participation in agreements concluded within this Association in accordance with the provisions of the 1980 Treaty of Montevideo.

In this connection, Mexico has duly signed the following partial- and regional-scope agreements:

A. Partial-scope agreements on renegotiation of preferences granted during the period 1962-1980

This concerns the partial-scope agreements concluded under Resolution 1 of the Council of Ministers whereby concessions granted by that country in its national schedule and its lists of non-extensive benefits applicable in LAFTA up to 31 December 1980 are incorporated into the new integration scheme, namely:

As can be seen, Commercial Agreements Nos. 26 and 27 were concluded after submission of the September 1984 report. The Governments of Argentina and Brazil are also parties to those agreements.

C. Regional-Scope Agreements Nos. 1, 2, 3 and 4

Obviously, by definition, Mexico is also a party to Regional-Scope Agreements Nos. 1, 2 and 3 on the Opening of Markets in Favour of Bolivia, Ecuador and Paraguay, respectively; and to Regional-Scope Agreement No. 4, which introduces the Regional Tariff Preference (see report of September 1984, item 2(A) and (B)).

2. In 1985 and 1986, the countries members of the Association carried out their negotiating activities through the mechanisms established by the 1980 Treaty of Montevideo.

In that connection, it should be noted that nearly all the agreements concluded up to 1984 underwent amendment (more detailed or adjusted standards; prolongation; renewal or modification of preferences; additional notes regulating the import of negotiated products; etc.).

In addition, individual member countries, parties also to the General Agreement, signed new partial-scope agreements in accordance with the provisions of the 1980 Treaty of Montevideo, namely:

A. Economic complementarity agreements

Agreement No. 4* and its Amending Protocol No. 4.1 concluded by Chile and Uruguay aims at intensifying and diversifying trade between the signatory countries; stimulating the economic complementarity of such trade and ensuring fair competition conditions; and developing their industrial activities so as to achieve greater efficiency in their production systems.

Agreement No. 5 and its Amending Protocol No. 5.1, concluded by Mexico and Uruguay, aims at intensifying the economic and trade relations between the signatory countries in the context of the integration process established by the Treaty; increasing and diversifying, at the highest levels possible, the trade between them on reasonable bases of balance;

facilitating the preparation of special programmes, such as counter-trade (inter-cambio compensado), etc.; co-ordinating and complementing economic activities, especially industrial activities and related technologies, by improving production systems and scales of operations; stimulating investments aimed at intensive utilization of the markets and the competitive capacities of signatory countries in world trade flows; and facilitating the creation and functioning of regional bi-national and multi-national enterprises.

This Agreement voided Renegotiation Agreement No. 39 on historic heritage signed by the two Governments, to which reference is made in the report of September 1984.

Agreement No. 6 and its Amending Protocol No. 6.1, concluded by Argentina and Mexico, aim at: intensifying and diversifying the trade between them at the highest possible levels; promoting increased trade by ensuring the strengthening, on stable foundations, of the earlier understanding adopted by the two countries to encourage counter-trade programmes; co-ordinating and complementing economic activities, particularly industry and related technology, through efficient improvement of structures and scales of production; stimulating investments aimed at intensive utilization of the markets and competitive capacities of the signatory countries in world trade flows; and facilitating the creation and functioning of regional bi-national and multi-national enterprises.

This Agreement is to be further improved as regards liberalization mechanisms, among which it is worth drawing very particular attention to the institutionalization, for the first time in the Association, of a régime of counter-trade between the two countries.

Agreement No. 7 and its Amending Protocol No. 7.1, concluded by Argentina and Brazil, aims at regulating the production, trade and technological development of capital goods.

B. An Agreement on Tourism (Agreement No. 1) concluded by Bolivia and Uruguay, has the aim of establishing conditions favourable to increased tourism between the two countries with a view to contributing to greater awareness of their peoples of their history, culture and geography.

GENERAL NOTES

- (1) ARGENTINA: The Argentine Republic has decided that, until such time as a legal norm making the concessions granted effective is adopted, goods covered by any of the mechanisms provided for in the 1980 Treaty of Montevideo will be shipped under the conditions under which they were negotiated, subject to the guarantee régime specified in Section V, Title III of the Customs Code (Decree No. 3.721 of 28/XI/1984, document ALADI/CR/di 82.4).
- (2) CHILE: By virtue of the authority vested in him by Article 1 of Decree Law No. 2.554/79 and in the light of the provisions of Articles 1 and 2 of Law No. 18.525, the National Director of Customs has concluded that the tariff preferences granted under the 1980 Treaty of Montevideo apply as from the moment of signature of the document approving the relevant agreement, unless the document stipulates a time period or condition for the entry into force of the agreement (National Customs Service Circular, No. 299 of 16 July 1986, published in document ALADI/SEC/di 222).

- (4) URUGUAY: The Eastern Republic of Uruguay has decided that "international undertakings entered into in the legal framework of LAIA in the matter of regional-scope agreements and partial-scope agreements (trade, economic complementarity, agricultural, trade promotion or other agreements) shall become fully effective as from the date stated in the relevant protocol" (Decree No. 663 of 27/XI/1985, Article 1, document ALADI/SEC/di 202).
